WHAT IS A COMMUNITY?

Think about the communities you are a part of...what do you have in common with the other members? You probably have some shared interests, values, beliefs and ideas. Communities are groups that are motivated to come together and identify as a group because of the things they have in common. In this assignment, you'll focus on how food relates to the common interests, values or beliefs of one of your communities.

ASSIGNMENT

In this paper, you will draw directly on the readings from *Mirror on America* and outside resources to support a claim you make about how food is used in your community to convey community values and/or community identity. Like the previous paper, this paper will take the form of an essay with a thesis, supporting paragraphs and the use of source material to support your claims.

This paper might discuss and analyze a particular festival or event that revolves around food, a particular type of food grown or manufactured in your community, or a particular tradition in your family, group of friends, or community that is related to food.

Your goal is to demonstrate how food is used in your community to express, share, and pass on values to other members of the community and to support your claims with the outside readings.

Your paper needs to be 2-3 pages and to include at least 2 sources, 1 from the assigned readings and 1 you locate on your own. You must summarize 1 of the sources, rather than taking a direct quote from it.

STARTING POINTS FOR FOOD, FAMILY & COMMUNITY

- What communities are you a part of?
- What is important to my communities? What types of things do they support or endorse?
- What is unique about my communities?
- How is food connected to being a member of a community?
- What other events or actions are connected to a particular food?
- Are there stories or messages connected to particular foods?

FORMAT

Your Food, Family, & Community Project should follow standard writing conventions and the following format:

- You will need to give your project an interesting and relevant title (Not Food Paper).
- Your paper needs to have a heading (APA papers typically require a title page, but a title page is not required in this class.)
- Your paper needs to have a header in APA style
- Your paper should be double-spaced, with 1 inch margins, and 11 or 12 point font. Please use standard fonts such as Calibri or Times New Roman.
- You need to cite your sources in APA style and include an APA style Works Cited page.
 THE WORKS CITED PAGE DOES NOT COUNT IN THE PAGE REQUIREMENT.
